You are invited and encouraged to review and comment on preliminary updates to three important and closely related Hawai'i HEER Office TGM sections covering hazardous chemical release (or suspect release) site investigation planning, investigation implementation, sampling strategy, and sample collection methods for soil and sediment. The updates reflect experience gained by HEER staff and input from the consulting community since original publication of the quidance in November, 2008. The updates have been posted for on-line access from the HEER Office website (http://hawaii.gov/doh/heer), in the "What's New" section on the homepage.

A summary of the updated subsections is included with the posted documents. The updates include significant additions to text, figures, tables, and examples that we hope will serve to clarify the guidance, enhance understanding, and further assist users to conduct high quality environmental investigation work.
